## NYCU Regulations Governing the Review of Subsidies for Faculty Members to Present Academic Outcomes at International Conferences

Approved at the 2nd R&D Executive Committee Council on June 14, 2022

Approved at the 7th R&D Executive Committee Council on September 19, 2023

- 1. In accordance with Article 4 of the "NYCU Guidelines for Faculty Members' Subsidy for Presenting Academic Outcomes at International Conferences ", the University has established these regulations to facilitate the review of applications for subsidies.
- 2. The "international conferences" mentioned in these regulations are based on the list of the top and important international conferences of the year provided by each college of the University. The faculty may apply for international conferences on a college basis and apply across departments within their respective colleges.
- 3. Applications for subsidies for faculty researchers to present at international conferences are based on the principle of partial subsidies, with the maximum subsidies shown below:

(a) If a faculty member applies for a subsidy to attend a top international conference across departments within the college, the subsidy will be calculated with 20% off the maximum subsidy for that conference; if a faculty member applies for a subsidy to attend an important international conference across departments within the college, the subsidy will be calculated with 10% off the maximum subsidy for that conference. The amount of subsidy will be determined by choosing the best method of subsidy based on the list of meetings of the original department or the list of cross-departmental meetings within the college.

(b) In case of attending video conferences, only the registration fee will be subsidized.

- 4. The priority of subsidies is as follows: (1) Top and important international conferences that are not subsidized by other organizations; (2) Top and important international conferences that do not receive enough subsidies from other organizations.
- The tasks of the international conferences for which subsidies are applied are:

   (a) Oral Presentation of Academic Outcomes, (b) Poster Presentation of Academic Outcomes, (c) Academic achievements in creative presentations, including new audiovisual media, multimedia, spatial curation, and interactive technology.
- 6. If an applicant participates in an international conference and signs the paper with the name of the author's country as China or Taiwan, China, etc. in a way that is not in line with the overall interests of our country, which will degrade the status of our country, the subsidy shall be rejected.
- 7. These regulations shall come into effect after being approved by the R&D Executive Committee Council.
