Regulations Governing the Review of Subsidies for Faculty Researchers to Present at International Academic Conferences

Approved at the 2nd R & D Standing Committee Meeting on June 14, 2022

- 1. In accordance with Article 6 of the "Guidelines for Subsidies for Faculty Researchers to Present at International Academic Conferences", the University has established these regulations to facilitate the review of applications for subsidies.
- 2. The "international conferences" mentioned in these regulations are based on the list of the top and important international conferences of the year provided by each college of the University, and conferences not on this list are considered general international conferences. The faculty may apply for international conferences on a college basis and apply across departments within their respective colleges.
- 3. Applications for subsidies for faculty researchers to present at international academic conferences are based on the principle of partial subsidies, with the maximum subsidies shown below:

Importance of the conference	Maximum subsidy principle
Top international conferences listed by the affiliated departments	NT\$100,000 for Europe / NT\$80,000 for the USA and Australia / NT\$60,000 for Asia
Important international conferences listed by the affiliated departments	Oral presentation: NT\$60,000 for Europe / NT\$48,000 for the USA and Australia / NT\$36,000 for Asia Poster presentation: NT\$40,000 for Europe / NT\$32,000 for the USA and Australia / NT\$24,000 for Asia
General International Conference	Oral presentation: NT\$50,000 for Europe / NT\$40,000 for the USA and Australia / NT\$30,000 for Asia Poster presentation: NT\$33,000 for Europe / NT\$27,000 for the USA and Australia / NT\$20,000 for Asia

- a. If a faculty member applies for a subsidy to attend a top international conference across departments within the college, the subsidy will be calculated with 20% off the maximum subsidy for that conference; if a faculty member applies for a subsidy to attend a important international conference across departments within the college, the subsidy will be calculated with 10% off the maximum subsidy for that conference. The amount of subsidy will be determined by choosing the best method of subsidy based on the list of meetings of the original department or the list of cross-departmental meetings within the college.
- b. In case of attending video conferences, only the registration fee will be subsidized.
- 4. The priority of subsidies is as follows: (1) Top and important international conferences that are not subsidized by other organizations; (2) Top and important international conferences that do not receive enough subsidies from other organizations; (3) General international conferences that are not subsidized by other organizations; (4) General international conferences that do not receive enough subsidies from other organizations.

- 5. The tasks of the international conferences for which subsidies are applied are: (a) Oral Paper Presentation, (b) Chairing and Presenting Papers, (c) Poster Paper Presentation, (d) Plenary Talk or Keynote Speaker.
- 6. If an applicant participates in an international conference and signs the paper with the name of the author's country as China or Taiwan, China, etc. in a way that is not in line with the overall interests of our country, which will degrade the status of our country, the subsidy shall be rejected.
- 7. These regulations shall come into effect after being approved by the R & D Standing Committee.
